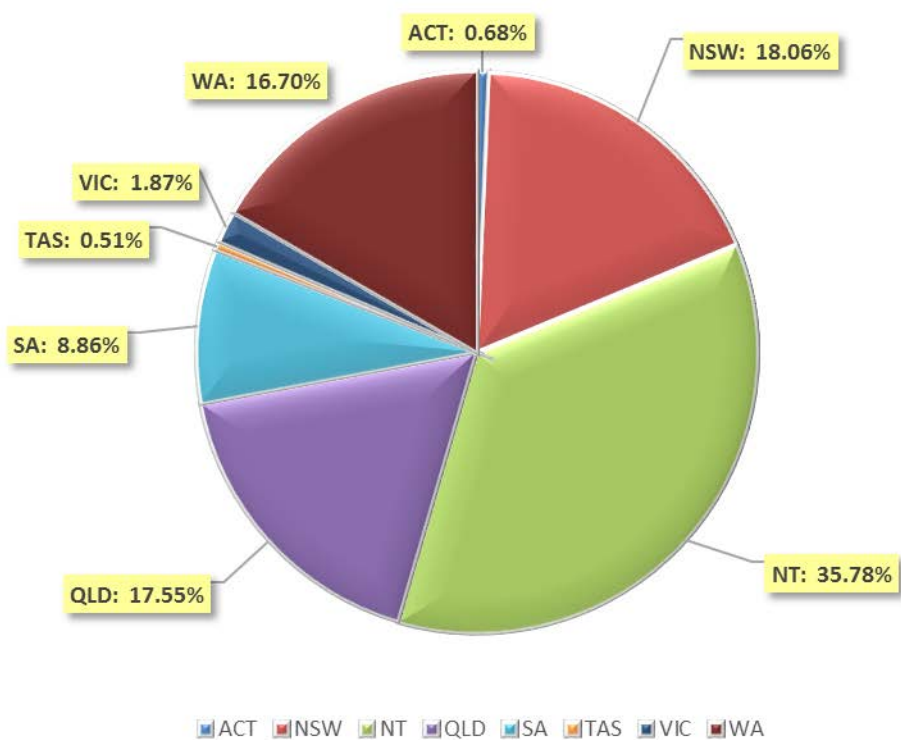

**Table 2.1 Percentage by Principal Place of Practice**



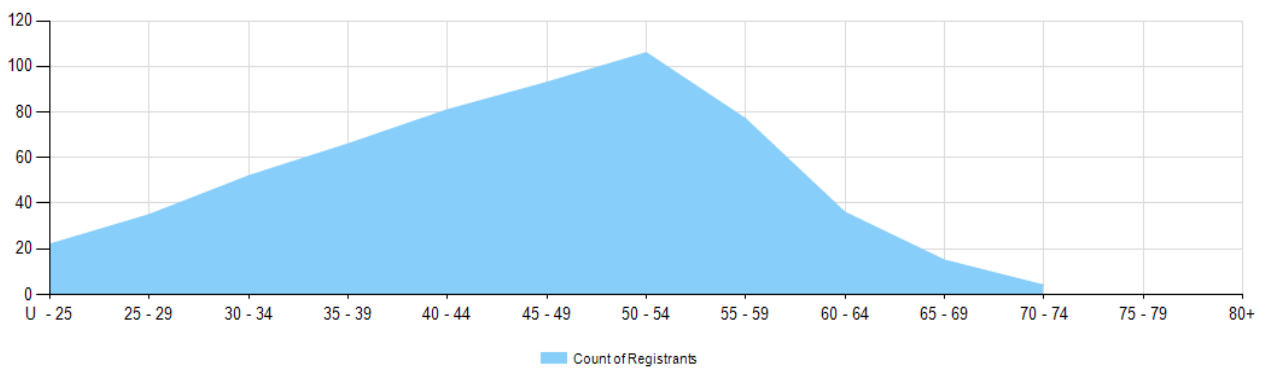
