February 2017 meeting of the Aboriginal and Torres Strait Islander Health Practice Board of Australia

Introduction

The Aboriginal and Torres Strait Islander Health Practice Board of Australia (the Board) works in partnership with the Australian Health Practitioner Regulation Agency (AHPRA) to implement the National Registration and Accreditation Scheme (the National Scheme). Details about individual Board members can be found on the Board's <u>website</u>.

The Board's most recent quarterly meeting was held on 22 February 2017, in Melbourne. The whole Board meets as the Registration and Notification Committee (RNC) almost monthly to consider registration and notification (complaint) matters.

February meeting

During its meeting on 22 February, the Board received reports from the RNC. It also addressed a number of AHPRA and National Scheme-related matters.

Board vacancies

Every time a Board member comes to the end of their term on the Board, the vacant position is widely advertised in newspapers and on the website (<u>www.atsihealthpracticeboard.gov.au</u>). First workshop on developing an Aboriginal and Torres Strait Islander Health Strategy for the National Registration and Accreditation Scheme

At their combined meeting in September 2016, National Boards, AHPRA and accreditation authorities discussed how to best work together to support better health outcomes for Aboriginal and Torres Strait Islander people.

The goal of the workshop was to identify the National Scheme's strategy and role in ensuring patient safety for Aboriginal and Torres Strait islander peoples in Australia's health system.

The first workshop was an initial discussion to identify the goals and possibilities of action in a strategy. It is expected that a further, larger summit will be convened to ensure engagement and alignment with other efforts.

Review of registration standards

The Board has completed the preliminary consultation phase of its review of registration standards in conjunction with the other National Boards that started under the National Scheme in 2012. The registration standards that are being reviewed are:

- professional indemnity insurance arrangements (PII)
- continuing professional development (CPD)
- recency of practice (RoP)
- English language skills, and
- Aboriginal and/or Torres Strait Islander registration standard.

The Board thanks all those trusted stakeholders who provided feedback in the preliminary consultation round. The next step is to consider the feedback, adjust the revised draft registration standards and guidelines as needed, and then publish them for public consultation, in 2017.

The Board is keen to get your feedback on the proposed draft changes to the registration standards (some changes are small, some are major).

In the meantime, the currently published registration standards remain in force.

Standards compliance audit

All health practitioners registered under the Health Practitioner Regulation National Law, as in force in each state and territory (the National Law), are required to comply with a range of registration standards.

These standards were developed after wide-ranging consultation and have been approved by the Australian Health Workforce Ministerial Council. Please refer to the Board's <u>registration standards</u> page for additional information and resources.

Last year the Board participated in an audit of registration standard compliance. In the coming months, AHPRA will again randomly select Aboriginal and Torres Strait Islander health practitioners to audit their compliance with the Board's registration standards.

Annual report summary

The <u>annual report summary</u> provides a snapshot of our work regulating almost 600 registered Aboriginal and Torres Strait islander health practitioners for the 12 months ending 30 June 2016.

State and territory annual report summaries

Individual annual report summaries for each state and territory, offering insights into how the National Scheme is operating in each jurisdiction, have now been published.

Based on the AHPRA and National Boards annual report for 2015/16, the summaries are available <u>online</u> on <u>AHPRA's website</u>.

Information includes applications for registration by profession, outcomes of criminal history checks and segmentation of the registrant base by gender, profession and specialty.

Notifications information includes the number of complaints or concerns received by AHPRA by profession, types of complaint, matters involving immediate action, monitoring and compliance, panels and tribunals, and statutory offence complaints.

Employer obligations

If you employ registered health practitioners, you have an important obligation to ensure that they hold current registration and that you understand your mandatory notification requirements under the National Law.

AHPRA has published <u>resources</u> to help you understand and meet your obligations, which are designed to complement your recruitment requirements and processes. These materials state exactly what your obligations are and it is important that you are familiar with them.

Registration

Approved programs of study

There are now eleven programs of study that have been approved by the Board for the purposes of registration. More are coming on line as they are accredited and approved by the Board. The list of <u>approved programs of study</u> is published on the Board's website.

Renewal of registration

The renewal of registration period ended on 30 November 2016. Under the National Law practitioners who do not renew their registration within one month of their registration expiry date must be removed from the register. Their registration will lapse and they will not be able to practise as an Aboriginal and/or Torres Strait Islander health practitioner. The fast-track application process that could be utilised during January has now closed. Practitioners who have missed the renewal process should contact the Northern Territory AHPRA office on 1300 419 495. People who have missed the renewal process must not practice until their registration is renewed.

AHPRA sends renewal reminders to practitioners who have provided an email address. See below on how to update your contact details with AHPRA.

Top tips for using the register

The <u>national register of practitioners</u> is core to all the work of the Board, as it provides up-to-date information about every registered health practitioner. To help the public and employers get the most out of the register, we have developed <u>these tips</u>. In particular, the tips remind anyone responsible for recruiting health practitioners how to use the register to verify a practitioner's registration status.

Are your contact details up to date?

It's important to make sure that your contact details registered with AHPRA are up to date so you don't miss reminders to renew or important information from the Board. You can check your contact details via the Login icon at the top right of the AHPRA website.

Email accounts need to be set to receive communications from AHPRA and the Board to avoid misdirection to an account junk box.
